GSDC OF CENTRAL OHIO, INC. BOARD MEETING
WEDNESDAY, OCTOBER 15, 2014

The meeting was called to order at 7:40 p.m. at Iacono's Restaurant, Hilliard by president John Ayotte. All officers and board were in attendance.

Minutes of the September membership meeting were read. Joe LaRosa moved the minutes be approved as read, seconded by Teri Ayotte. Minutes were approved.

Treasurer's Report: Sue Clark gave the report. The club received \$491 in donation in Mike Hukle's memory. Teri Ayotte moved the report be accepted, seconded by Joe LaRosa. The motion passed.

Committee Reports: Our newsletter won in its category at the National. Kathi Jo Zornes was notified by chair Sue Sacco.

Specialty Shows: John Ayotte is working on a draft to the Trumbull County Kennel Club regarding the possibility of both clubs having classes for German shepherd dogs even though the distance would ordinarily put clubs in conflict with each other. He is also going to contact Roberts Arena to ask if they could come down on the \$500 quoted for use of the facility. There was a discussion regarding the risks of moving our shows or making an agreement with Trumbull County Kennel Club. Jon White stated that the GSDC Of Miami Valley lost their date to an all-breed club when they moved their date to host a futurity. It was also observed that we cannot hold AKC to such an agreement and they would likely award German shepherds to Trumbull County. Suggestion was that we investigate possible sites off I-71 south of Columbus. Since we were awarded the futurity in 2016, we should aggressively pursue this. John Ayotte said that Cincinnati's specialty judges are D.D. Ardoin and Cindy Flautt.

Agility: Marcy Wright reported she has no news as her contact just had a baby and is busy with getting the new facility running.

New Business: John Ayotte asked if there were any items that needed to be addressed in the standing rules. No one proposed any changes John received a request from Jeff Pyle for a membership application. He asked if we would waive the initiation fee, and the board agreed unanimously.

Teri Ayotte asked if we would like to hold our Christmas and awards party at Max And Erma's on Hamilton Road again. Everyone was agreed. After discussion, the date of Monday, December 15, was chosen.

The November meeting is scheduled Wednesday, November 19. It will be held at Iacono's, Hilliard. Kathi Jo Zornes moved meeting adjourn. The meeting adjourned at 8:45 p.m.

WEDNESDAY, NOVEMBER 19, 2014

The meeting was called to order at Iacono's Restaurant, Hilliard at 7:45 p.m. There were thirteen members in attendance.

Minutes from the October 15, board meeting were read. Charlotte LaRosa moved the minutes be approved, seconded by Kathi Jo Zornes. Minutes were approved as read.

Treasurer's Report: Sue Clark reported that the club shows a loss for this period. The club showed a profit for the year. She paid our insurance as it was due and falls under authorized expenses. Joe LaRosa moved the report be approved, seconded by Kathi Jo Zornes. The report was approved.

Newsletter: Kathi Jo stated that the next newsletter is due out on December 7. She requested news be submitted by December 7.

Membership: Marcy Wright reported she gave her information to a Ms. Friday at the dog show on November 16. To date she has not been contacted. Jeff Pyle submitted his and Mike Little's application (for records) to rejoin club.

Specialty Shows: John Ayotte reported that Roberts Arena area is off the table because they are converting the open area into a campground. There are no hotels in Grove City or Hilliard area with any significant space. He will check some prospective sites near the Jeffersonville outlet malls to see if any have sufficient space for ring setup for shows and futurity (2016). We'll continue at our present site for 2015 unless circumstances make it unavailable. Marcy Wright will check on the recreation center near Dublin to see if it has enough space for a 50 x 100 foot ring, adequate parking, and facilities. John is working on a letter send to Trumbull County Kennel Club regarding our clubs sharing the date for German shepherds. If a site is selected in Jeffersonville area, we will be over 200 miles from the Trumbull County shows. The question was raised about holding obedience with our specialties. We are not holding obedience for 2015. Our last trial was 2012 so we are eligible to hold obedience before 2017 without re-qualifying.

Marcy Wright reported that she spoke with Jennifer Crank of Incredipaws regarding agility trials. She provided a list of open weekend dates. Our preferred date for a trial is July 11 - 12. We need to hold an agility match before that. We will likely lose money on the match, but trials should clear \$400 to \$450. Marcy will work with Jennifer to set something up. Since we have a some money to work with, this is be a good time to do this. We prefer to hold our match on a Friday before an agility trial. Incredipaws is located in Pataskala, just off I-70 at Exit 118.

Christmas And Awards Party: Teri Ayotte reported she has arranged for us to hold our party at Max And Erma's Gahanna on Monday, December 15. Rosemary Booth moved the club pay \$10 for each member's meal, seconded by Teri Ayotte. The motion passed. Those attending have the option of participating in exchanging dog gifts. The board will hold a short meeting.


Training: Discussion was held about using of Ganyard building at the fairgrounds. Sue Clark said cost of building is \$100 a night. Jon White proposed that members using the building split \$50 a night. She said that Tim Shade said there is an outdoor area on the fairgrounds that could be rented for \$250. Kathi Jo Zornes volunteered to conduct AKC S.T.A.R. puppy classes over a six-week period. Those completing the course are eligible for a certificate from AKC. Kathi Jo will need to order the paperwork for the class. She has Monday nights available. Jeff Pyle can conduct conformation training. Sue was asked to check if building will be available on Mondays. Dates will be set accordingly. We need to decide how best to publicize the program. Jeff stated that we need to utilize social media in addition to traditional newspaper ads since it reaches a large number through networking.

Charlotte LaRosa moved we hold a membership meeting January 21, weather permitting, in order to move forward with training options and show related items, seconded by Rosemary Booth. The motion carried.

Charlotte LaRosa moved the meeting adjourn. Meeting was adjourned at 8:35 p.m.

APPOLLO--HERO OF 9/11



NYPD German shepherd dog Appollo's coup--the 2001 ACE AWARD FOR CANINE EXCELLENCE in law enforcement--was scheduled to be announced on September 11. Instead, he and his partner, Officer Peter Davis, were called into action. "We got there right after the buildings collapsed. To get to the rubble, we had to go through almost waist-deep water. All of a sudden he disappeared, fell into a hole. Then this big fireball comes up and he comes running out. He was on fire. I brushed off the burning embers and he went right back to searching."

By age 9, when most police dogs have already retired to their handler's sofa, the big guy was working the pile. His thick coat singed by red-hot metal, his paws cracked and bruised by acres of jagged concrete, bone weary from days of double shifts, Appollo plodded through the rubble, searching in vain for the living.

When hope was lost, when Davis had to accept that even his mighty Appollo would not find a survivor, the tenacious shepherd had to be literally pulled from the debris. Whoever coined the phrase "working like a dog" must have known Appollo. It was typical of his doggedness that he clung to life for so long, before death overtook him at age 14.

Some of us from AKC staff were invited to observe K-9 Officer Pete Davis and his grizzled ACE winner search the rubble. To those who were privileged to witness it, Appollo's work at the World Trade Center site was his defining moment.

How Diet Can Affect Survival Time in Pets with Cancer

The diagnosis of cancer in a beloved pet can be devastating to pet owners. After all, our pets are furry family members. They give us unconditional love, companionship, and joy. The thought of losing that special friend can be overwhelming and terrifying. Many owners fear their pets will suffer horrible side effects from the chemotherapy, radiation therapy, or other cancer treatments. But not many people know how the food we feed our animals can improve the quality and length of life in animals with cancer. The battle against cancer begins at home with what you put in your pet's food dish.

Why do pets with cancer lose weight?

Many pets with cancer develop cachexia, which is a syndrome in which the animal loses weight and muscle mass due to the increased metabolic needs placed upon the body by the tumor cells. Cancer changes how the body metabolizes and utilizes carbohydrates, protein, and fat, so even an animal with a normal appetite may develop cachexia.

Tumors prefer to use glucose (sugar), which comes from carbohydrates, for energy. Veterinary cancer specialists believe this alters carbohydrate metabolism in dogs with cancer. When glucose is metabolized by the tumor cells, lactate (lactic acid) is formed. The body must then convert lactate back to glucose for the rest of the cells in the body to utilize as energy. This extra step in metabolism requires additional energy to be expended by the body, which creates a net energy loss and is one reason dogs with cancer develop cachexia.

Protein metabolism is also altered in animals with cancer. The tumor cells produce substances which trigger decreased production of new skeletal muscle, increased breakdown of existing skeletal muscle, and increased liver and whole body protein production, which support tumor growth. This is not only a leading cause of cachexia, but can also lead to decreased immune function, gastrointestinal function, and wound healing. Oncologists believe it is important that protein intake matches protein usage in cancer patients.

Cancer also changes the metabolism of fat. Decreased production of fat and increased catabolism of fat lead to weight loss by depleting the body's fat stores. The tumor cells produce substances which mimic the hormones that control fat metabolism. The tumor also produces substances which decrease the body's ability to use insulin and transport glucose into the rest of the body's cells for energy.

What diet should I feed my pet with cancer?

It is recommended by veterinary oncologists that the diet contains no more than 25% carbohydrates (dry matter content). Low carbohydrate levels will "starve" cancer cells and, in turn, result in lower lactate levels. Less lactate means less energy needs to be spent converting lactate to glucose for energy. Protein levels should exceed the amount found in most adult maintenance diets. Protein should be from a highly digestible source (high quality) and comprise 30 to 45% dry matter content in dog foods and 40 to 50% dry matter in cat foods. This may help alleviate the muscle wasting observed with cachexia in cancer patients.

One study suggested that a low carbohydrate, high protein diet in conjunction with other cancer treatments may reduce metastasis or spread of certain cancers. Diets that are relatively high in fat are thought to starve the tumor cells, as some cancers have difficulty using fat as an energy source. Diets high in fat may pose other health concerns in dogs though, such as pancreatitis. Specific recommendations for fat levels are not outlined, but most commercial maintenance diets are relatively low in their fat content (7-25% dry matter basis).

The addition of Omega-3 fatty acids (Eicosapentaenoic Acid [EPA], Docosahexaenoic Acid [DHA]) to the diet has also been recommended by some veterinary specialists. Animal studies have shown that Omega-3 fatty acids may help preserve fat stores in the body by inhibiting fat catabolism and help decrease muscle (protein) loss. This can reduce the amount of weight loss associated with cachexia and may lead to increased survival time and quality of life in animals with cancer.

As with any medical condition, we recommend discussing your pet's nutritional and dietary needs with your veterinarian. Your veterinarian knows your pet's unique needs and full medical history. But the evidence is quite convincing that the food we feed our pets can vastly influence how the body responds to cancer and can potentially give us more quality time with our beloved four-legged friends.

Midnight Sun, A Remarkable Police Dog (1926)

Midnight Sun was a gorgeous German shepherd that became the hero of Okmulgee, Oklahoma, a small town in central Oklahoma. Midnight Sun's claim to fame? He proved to be an excellent Midnight Sun police dog.

Midnight Sun was a purebred German shepherd owned by a local oil man by the name of W.H. Gragg. Gragg frequently brought the dog into town with him, and Sun was a very handsome dog who made quite an impression with his creamy tan coat and his coal black saddle and black nose. Some of the higher-ups on the police force knew that other cities were experimenting with using dogs to aid with police work, and Okmulgee's high number of burglaries had gotten police attention. However, dogs used in police work were not common at the time. (The first police dog is thought to have been used in New York City in 1907.)

When Okmulgee's crime problem became such that they felt they needed extra help, the choice of turning to a canine was not made lightly. Someone suggested approaching Gragg about adding his dog to the police force. Gragg agreed, and the dog was sent to Herr Benno Stein, a well-known trainer of shepherds.

The force's Captain Stewart became Midnight Sun's primary handler, and Sun was described as obedient and affectionate with those with whom he worked.

Midnight Sun's Esteemed Record

Midnight Sun quickly earned an excellent reputation. According to an article in the American Kennel Club Gazette (8-31-1927), eighteen criminals captured in Okmulgee during one of Sun's first years on the force (1926) were due to the addition of the dog. Because of the drop in the crime rate, he became beloved by the citizens of Okmulgee.

German Shepherd Midnight Sun was soon in high demand by other police forces both within Oklahoma and outside the state. The article noted that the criminals were now "giving Okmulgee wide berth," so the police force was willing to loan him out on an as-needed basis.

Several stories of captured criminals were included in the AKC Gazette article about Midnight Sun, but my favorite was the description of what happened with the "ice pick burglar," Henry Clay.

The Ice Pick Burglar

Clay's primary burglary tool was an ice pick that he filed down to be needle-thin. From the sound of his work methods, he must have razored around the edge of the window screening so that he could lift a flap of the screen to get into a window.

Once inside a home he had a very consistent methodology. He removed from the house men's trousers and ladies' pocketbooks. He never tinkered with safes or opened a drawer looking for jewelry. He simply tossed trousers and pocketbooks out into the yard until he was satisfied he had them all.

When he climbed back out of the window, it seems he put the screen back more or less in place. He then sorted through the purses and the pockets in the pant looking for valuables which he then took with him.

That was in the days before Midnight Sun.

Sun was brought to a house following a job done by the "ice pick burglar." He picked up the scent of the burglar from the screen and proceeded to follow Clay's trail. Clay appeared to have run out of the residential area into the heart of the city where there was heavy traffic. Despite the fact that many cars and people had crossed and re-crossed the route Clay traveled, Sun trailed Henry Clay for more than 15 blocks.

Clay was captured and later sentenced to 18 years.

Midnight Sun received a gold medal for his work, and the police received a \$1,000 reward for their work (there is no explanation as to why a police force was eligible for a reward).

Midnight Sun's scent work was first-rate and effective in a day when a criminal was likely to travel by foot, and certainly Sun's success was to help pave the way for the advanced police work now done by dogs for search-and-rescue, bomb detection, arson, and cadaver dogs as well as plain old guard dogs.

The purpose of this message is to make all kennel clubs aware of two valuable tools which the ADSJ has developed to assist show-giving clubs. The first is our photo directory which you will find at http://www.adsj.org/judges_photo.htm. This tool enables a club to put a face with a name. When discussing the makeup of a show panel and a judge's name is mentioned that may not be familiar to the entire committee, this online directory can be a great help. Simply look up the name then click on the thumbnail photo to make it larger. By clicking on the name you will be brought to the judge's individual AKC page where you can check on the judge's approved and permit breeds, contact information, initial breed and availability. If you are not already using this directory, do try it out. I'm sure you will appreciate what a help it can be when your show committee is putting together a judging panel. As an added bonus, judges with an asterisk after their names are not yet group judges and may have permit breeds. Hiring these judges qualifies as an educational credit for your club with the AKC.

The second tool is the ADSJ Protocol Booklet and Sample Contract, subtitled, "Guidelines for Show-Giving Clubs and Judges." If you do not have the latest edition of this useful booklet, please go to <http://www.adsj.org/Protocol%20Booklet%20Order%20Form.pdf> where you will find a summary of the booklet contents and an order form. The \$3.00 cost just covers the printing and postage. Some clubs have ordered multiple copies for their show committee members. Our feedback from clubs regarding this publication has been very positive. It is especially useful for new show chairs.

Winterizing Your Pets: Ten Tips

Oh, the weather outside is frightful! Winter weather is rapidly approaching and you've likely begun layering your clothing and weatherproofing your car. When organizing for winter, don't forget to think about your pets. They too are deserving of special treatment this time of year. Here are ten tips for keeping your pets cozy, comfortable, and healthy this winter:

1. Just as arthritis can be more problematic for us when the temperature drops, so too does this apply to our animals. If your best buddy appears stiff first thing in the morning or is more tentative when navigating stairs or jumping up and down off the furniture, I encourage you to contact your veterinarian. These days, there are so many beneficial treatment options for soothing arthritis discomfort. For your pet's sake, make the effort to learn more about them.
2. When the temperature drops, outdoor kitties like to snuggle up against car engines for extra warmth. Be sure to provide plenty of notice before you start up your engine lest a "kitty squatter" sustain serious injury as a result of moving auto parts. Vocalize and tap the hood a few times. Better yet, lift the hood to alert any slumbering guests of your intentions.
3. Antifreeze is terribly toxic for dogs and cats. Even a few licks of the stuff can cause kidney failure and severe neurological symptoms, usually resulting in death. Unfortunately, most antifreeze products have a sweet flavor making them appealing to dogs. Cats are too discriminating to voluntarily taste the stuff, but should they step in antifreeze, they will ingest enough to be toxic during their grooming process. Please prevent your pets from having any access to antifreeze by checking under your vehicles for leaks and storing antifreeze containers in a safe place.
4. Wintertime is definitely dress-up time for dogs, when the clothing is functional rather than just adorable. Just like us, many dogs are more comfortable outside when wearing an extra layer. Smaller dogs in particular have difficulty maintaining a normal body temperature when exposed to freezing conditions. If the love of your canine life happens to be an arctic breed (Malamute, Husky, Samoyed), no need for canine clothing!
5. Regardless of season, all animals need access to water round-the-clock. If your pet is reliant on an outdoor water bowl, strategize a way to prevent the water from freezing. Water bowl heaters work well. Additionally moving water is more resistant to freezing- consider creating a little "drinking fountain" for your pets.
6. Sure the weather is cold, but your dogs still need plenty of exercise for their physical as well as their psychological well being. Besides, there's nothing quite like the feeling of relaxing by the fire with a content and tired dog at your side! If the weather is truly too inclement for both of you to be outdoors, look for an indoor dog park or consider doggie day care, assuming your dog enjoys such venues.
7. I'm all for hiking with dogs off leash, but in winter, be extra cautious around ponds and lakes for fear of thin ice. Not only is falling through the ice life threatening for dogs, it creates a situation that often becomes life threatening for the humans involved in the rescue operation.
8. Salt on sidewalks and roads and even ice that adheres to all of that fuzzy hair between your dogs toes can create irritation and sores. Inspect and rinse your dog's tootsies as needed.


9. I strongly encourage having dogs and cats live indoors. If your living situation absolutely prevents this, and there are no other viable alternatives, please provide your pet with an enclosed shelter that is warmed by a heating device and contains plenty of clean, dry bedding. Also, remember that your pet needs just as much attention from you in frigid temperatures as during the warmer seasons.

10. 'Tis the time of year when we humans tend to overindulge, eating all kinds of things we shouldn't. Don't allow your pets to become a victim of this holiday spirit. In addition to adding unwanted and unhealthy pounds, eating rich and fatty foods predisposes them to gastrointestinal upset and pancreatitis either of which could land your four-legged family member in the hospital for several days (not to mention create some significant rug-cleaning expenses for you).
