

BREAKING NEWS: House Bill 94 Proposed to Help Dogs

Will chaining dogs up finally become against the law in Ohio?

Ohio dog owners who leave their pets tethered in extreme hot or cold, overnight or while away from home would be subject to a fine and possibly jail time under a bill introduced Monday, March 2, 2015 in the Ohio House.

House Bill 94 would make tethering an animal under the following conditions illegal:

- * for longer than six consecutive hours in a 24-hour period
- * between 10 p.m. and 6 a.m.
- * if a heat or cold advisory has been issued by the National Weather Service
- * if the rope, chain or similar restraint is less than 20 feet long
- * if no owner or occupant is present
- * if a choke, prong or ill-fitting collar is used
- * The proposed state law mirrors a Cleveland city ordinance passed in 2012.

Bill sponsor Rep. John Barnes Jr., a Cleveland Democrat, said he hopes the bill generates discussion about Ohio's animal cruelty laws and owner responsibility. "They're God's creations also so they should be treated as such," Barnes said.

House Bill 94 has bipartisan support, cosponsored by Republican Reps. Mike Duffey of Worthington and Margaret Ann Ruhl of Mount Vernon and Democratic Rep. Michele Lepore-Hagan of Youngstown.

Violators would be fined on a first offense. Fines would increase to as much as \$1,000 plus jail time for subsequent offenses or if the animal becomes sick or injured while tethered illegally.

Twenty-five states and Washington, D.C. have restrictions on tethering animals, according to the American Veterinary Medical Association.

Concerns from citizens expressed include concern on how the local authorities plan to enforce such law since other laws for animals often go unenforced, that the law is too broad & nonspecific, how some dogs tied up are a barking nuisance, how people who feel they need to chain up a dog in the back yard and not spend time with them shouldn't have a dog in the first place, and other comments.

My Dog Could Do Agility, But.... By Diana Dickinson

Eavesdropping at an agility trial, I heard:

My dog is too old. I'm too old. He's too slow. I'm too slow.

I don't want him to jump out of the yard. He's the wrong breed. Training costs too much.

I heard all of those statements over the past weekend, as I sat in the stands watching the agility competition at the Rose City Cluster of dog shows. This is a huge-big-deal dog show in Portland, Oregon. It costs \$10 just to come through the door as a spectator, and yet it's packed every single year. The vendors are great (and the shopping is sales-tax-free here in Oregon). There are lots of dogs showing in conformation and obedience and rally and agility. There are agility events Saturday and Sunday that are qualifiers for the World Team Tryouts for the top handlers and the top dogs. As I said, huge-big-deal dog show.

I listened to the spectators as I watched, because I'd love to see more teams come into the sport. It's a great sport. It's inspired me, over the ten years I've been competing, to improve my fitness and my dogs' fitness. It's brought me some wonderful friends. It's more fun than I could possibly have imagined when I started, back when my goal was simply to have something else to teach my mischievous and imaginative standard poodle.

Let me address these agility misconceptions, one by one.

Age: yours. Certainly, the human's age doesn't matter. There are agility competitors from age six to well-into-the-eighties. Dogs enjoy positive training so much-and positive training methods are important for agility—that you can train what you need to be successful. I've seen handlers who can barely walk move to the center of the arena and direct their dog from there. Yes, it's a training challenge, but it can be done. I've seen handlers who use a mobility scooter have fabulous runs with their dogs. Yes, training challenge. Yes, it can be done.

Age: the dog's. Well, yes, there are dogs that really shouldn't be training in agility. Dogs with structural issues that make walking painful or uncomfortable—such as hip dysplasia—will not enjoy jumping, and it's cruel to ask them to. Dogs that are old enough that life on the couch is their biggest pleasure might not enjoy agility either. Those situations aside, dogs don't need to be young to start agility training. You can start training with a middle-aged dog. All you really need to start agility training is a dog that is interested in playing with you. And if your dog isn't interested in playing with you, you can fix that by teaching the dog that playing with you is how they earn their breakfast and dinner.

Slow speed: yours. If you're slow, that's okay. You can train skills that make that less of a problem. Pretty much every handler with a dog that's more than a foot tall at the shoulders is slower than her dog. (Some of the really small terriers—the Cairn and the Yorkie come to mind—can be beaten by a quick runner.) We all train our dogs so that the dog's path is longer than the handler's, and that solves that problem.

Slow speed: the dog's. Dogs love to run. If your dog is overweight, though, he might be struggling to move quickly. As you start agility training, you'll need to keep the jumps very low and work to take excess weight off your dog. It's easier for dogs to lose weight than for people, though, because we people have complete control over their diets. Talk with your vet, but most dogs can lose weight if you reduce their food by about 10% and add in a walk every day. If your dog isn't overweight—if you can feel his ribs easily—and he's still slow, you can start selecting rewarding speed. Tell your dog to stay, then walk away, twenty feet or more. Start running away from your dog, as fast as you can, and reward your dog when he catches up to you, with a special treat like a chunk of cheese or hot dog or roast beef. If you do that a few times a day, pretty soon you'll have a dog that loves running fast and loves to play with you, too.

You're afraid your dog will jump out of the yard if you teach him how to jump. There are a few different answers to this. If your dog thinks being with you is fun, he won't want to jump out of the yard. Just because he can jump doesn't mean he will jump. Sometimes, teaching a dog to do

something for treats makes sure they won't do it if there aren't treats being offered. You know your dog better than I do; if your dog is an escape artist, teaching him to jump might actually make him a better escape artist. It might also make him want to stay home. My first standard poodle, Elly, was an incredibly adept escape artist. She could go under fences with a three-inch gap, through gates in a microsecond, and could jump three feet without a problem. She could unlatch gates, too. She never jumped over the fence out of our yard. A friend's Chesapeake Bay retriever, though, could climb six-foot fences. In my experience, though, teaching a dog to jump doesn't make him any more interested in escaping than he already is.

He's the wrong breed. There might be some truth in this. Some of the giant breeds-Great Danes, Leonbergers, Newfoundlands-find parts of agility very difficult. The dog walk can be challenging for a big dog-it's only 12" wide! The tunnels are only 24" tall and big dogs practically have to crawl through. But even a big dog can enjoy other aspects of agility, like the jumps and the opportunity to play with his handler. Little breeds face a different challenge. The teeter can be tough for a very small dog; the a-frame seems mountainous when a Chihuahua is scaling it. However, the little dogs can be very successful! Tigger, a Papillon handled by Robin Kletke, had achieved more than 38 MaCHs (Master Agility Championships) when he retired at age 14. Finally, there are heavy-boned breeds, like the bulldogs, who can find the jumps a challenge. They can still train in agility, although they may need lower jumps than other dogs of the same size.

Finally, training costs too much. Well, we all have hobbies. Agility training can be inexpensive, if you have a local training club or if you take advantage of online free training (check out Agility Nerd at http://agilitynerd.com/blog). You can train in your back yard and buy some equipment and some books. If you're so inclined, you can train with a top professional a few times a weekvia video or in person-and spend big bucks. To my mind, though, agility training and competition gives you a lot of fun per dollar!

* Note from Rosemary: I thought since we're considering running an agility trial, this might be of interest. I know I've believed that agility requires more quickness and athleticism than I have.



#### **AKC Canine Health Foundation Takes Aim at Periodontal Disease in Dogs**

Periodontal disease is the most common clinical condition in adult dogs, and if left untreated could cause extreme gum damage, tooth loss and pain. By three years of age, most dogs have some evidence of periodontal disease and associated discomfort. In an effort to speed progress in prevention and effective treatment of canine periodontal disease, the AKC Canine Health Foundation (CHF) has awarded two research grants to improve the oral health of dogs.

Dr. Paola Massari, PhD, of Boston Medical Center aims to develop an effective canine periodontal disease vaccine. She believes most effective targeted interventions against periodontal pathogens will be through effective immunization, directing a dog's own immune system to combat the bacteria responsible for disease.

Dr. Django Martel, DVM, and his colleagues at the Animal Medical Center will establish whether the use of antibiotic gel therapy reduces periodontal disease and provide veterinarians with the evidence needed for effective periodontal disease management.

According to Dr. Shila Nordone, CHF's Chief Scientific Officer, "Just like periodontal disease in humans, periodontal disease in dogs is a painful condition that profoundly affects quality of life and can lead to a multitude of health problems. We have strategically funded research that will have immediate impact by supporting the evidence-based use of antibiotic gels to treat progressive disease, while also funding research that will provide a long term solution by developing an effective vaccine to prevent the disease from occurring in the first place."



# AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- · Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.


