**GSDC OF CENTRAL OHIO, INC. MEETING  
WEDNESDAY, MAY 18, 2016**

The meeting was called to order at lacono's Restaurant at 7:46 p.m. There were twelve members and three guests present.

Minutes of the May membership meeting were read. Charlotte LaRosa moved they be accepted as read, seconded by Jon White. The motion passed.

Treasurer's Report: Sue Clark gave the report. The treasury shows a loss of \$294.07 for the period and \$666.26 for the year. Current checkbook balance is \$6,378. Charlotte LaRosa moved the report be approved, seconded by Joyce Willis. The motion carried.

Membership: Marcy Wright introduced Kim Quinn, Jennie McCutcheon, and Charles Gregory.

Specialty Shows: The matter of hospitality following the shows was discussed. Decision was to serve subs, chips, cheese, cookies, and drinks. Sue Clark and Marcy Wright will look for the best price for subs. Other supplies can be obtained at Costco. Desserts will be supplied by members. Charlotte LaRosa moved to limit cost to \$350, seconded by Joyce Willis. The motion was passed. Rings for the futurity must be 110' X 60' with 120' X 70' preferred. Ring setup will be after 5:00 p.m. due to Joe LaRosa judging in Cincinnati. Dave Rinke doesn't wish to be taken to dinner. Judging for the morning show will be 9 a.m. and afternoon show 30 minutes after judging is completed for first show. Jerry Guzman has arranged his own transportation to the hotel. Hospitality will follow judging of second show, tentatively 4 p.m. Rosemary Booth will make up and arrange printing of 4-part forms for the judges' books. Requests for trophies have been sent by mail and e-mail, and donations were taken at the meeting.

Futurity: Sue Clark has the catalogs and ribbons. Plaques haven't been delivered.

Secretary's Report: Contract for supported entry was received from Central Ohio Kennel Club for November 2016 and April 2017 shows. Submitted John Ayotte as specialty coordinator and myself as club officer submitting form. Changes can be made if decision is made to hold a concurrent specialty with COKC. Form was signed and will be sent to COKC. Check from Central Ohio Kennel Club was received in payment for supported entry and forwarded to Sue Clark. Sent membership card and notification of Lifetime Membership to Beverly Mills.

Unfinished Business: The changes of the club's constitution was distributed prior to and read at the April meeting. The proposed change was brought up for vote and accepted by unanimous decision. This will allow the club to proceed with plans for a mentored agility trial at Incredipaws. John Ayotte will contact Susan Crank regarding possible dates and steps we need to take in order to apply.

John Ayotte introduced the matter of holding a concurrent specialty with Central Ohio Kennel Club. Ring provided for both supported entry and specialty if we hold one will be 40' X 60'. COKC has a German shepherd judge for their show. We will not be charged for use of the facility and can provide our own show secretary. We need to hire our own judge and provide our own ring stewards and prizes. Consensus was that we don't have a suitable judge and stand to lose money. Suggestion was made to research open dates in September that would allow for combined specialties with The GSDC Of Greater Cincinnati at a shared site. Shows scheduled before the National should be well attended.

New Business: The membership of Kim Quinn was brought for vote. Kim was accepted into membership.

Clarks will be on vacation the week our meeting would normally be held. Date of the June meeting will be Wednesday, June 22. This will be a membership meeting and will be held at lacono's.

Joe LaRosa moved the meeting adjourn. Meeting adjourned at 8:50 p.m.

## **BREAKING NEWS: The GSDC of Central Ohio Gains AKC Agility License**

We are very proud to announce that, as of May 2016, our German Shepherd Dog Club of Central Ohio, Inc. has been approved by the American Kennel Club to host AKC Agility Trials in the coming months if our membership so decide.

This approval was granted after some digging and presenting of information by Club Board Member Marcy Wright. She petitioned the Club earlier this year, making her case of the benefits of hosting agility trials in multiple ways.

One aspect to allow this ability for our Club that had to be handled was an amendment to our Constitution and Bylaws.

Club Secretary Rosemary Booth drafted the paragraph change we needed to make in order for our Constitution and Bylaws to properly read that the Club would abide by the rules set forth for any type of American Kennel Club hosted trial [in general], changing the previous wording which included only obedience and rally trial capabilities. This was read, reread and approved by the officers and Board at monthly meetings earlier this year.

Another aspect of gaining this approval was that our Club had to have a least 5 members who is familiar with AKC Agility trials and have worked those such events or competed in such trials. This working knowledge is necessary so that we can have trial stewards and secretary who know how to properly set up courses, keep time on runs for recording, and so forth. Club Members Marcy Wright, Dave & Charlotte Brugger, Carolyn Farmer and Beverly Mills were the Club members who have agility experience that helped us get our approval without needing to host a Fun Match.

This new license allows us to offer German Shepherd owners yet another potential opportunity to do great things with their dogs regardless of type of pedigree breeding.

The notification of the approval was received by our Club Officers May 21, 2016 and posted to our Facebook page and social media.

## Continuing Education: Club Members Take Pet First Aid & CPR Course

German Shepherd Dog Club of Central Ohio club members Kathi Jo Zornes and Brandon Zornes attended the Jackson Emergency Medical Response Group's Pet First Aid and CPR Certification Course on Wednesday April 22 at the Ohio State University Extension Office in Jackson, Ohio. The course was taught by Jackson EMS Team Member Lori Simpleton who has served a number of years as a vet tech for Shawnee Animal Clinic & Wheelersburg Animal Hospitals as well as took college courses ideal for veterinarians. The dog used for live demos and practice is active registered therapy dog Jazz, a black Labradoodle TDI certified by Kathi Jo Zornes in 2013.

The group of 14 that took the course consisted of dog club members, groomers, EMTs, humane society officers, and caring pet owners.

The course consisted of several parts covering field techniques for making muzzles, how to properly carry an injured dog, putting together a first aid kit, coming up with a disaster response kit for your dog in the case of an emergency, normal vital signs for dogs and cats, how to give proper CPR to a dog and cat, handling and other useful information. A more comprehensive book on Pet First Aid and CPR was provided for purchase at \$16 a copy. The course was concluded with a test. Everyone who passed the test received a Pet First Aid & CPR certification card.

As our Club's AKC Show Secretary, Kathi Jo felt this a worthwhile and necessary education in light of the dog shows our club hosts annually and the Great Lakes Futurity we hosted this year. While we would certainly hope that there'd be no accidents, our Club will now have people educated in Pet First Aid & CPR present on our show site during our AKC shows this year!

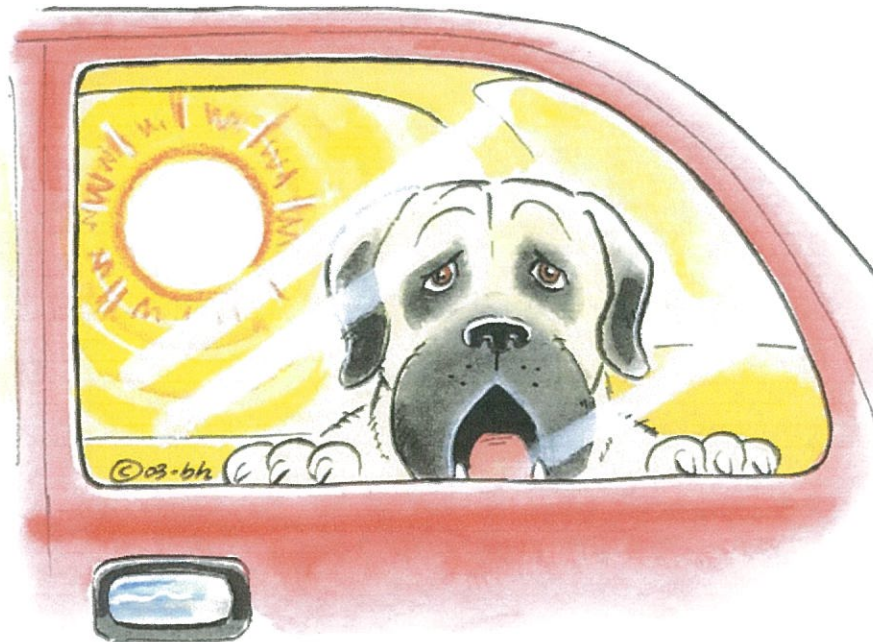

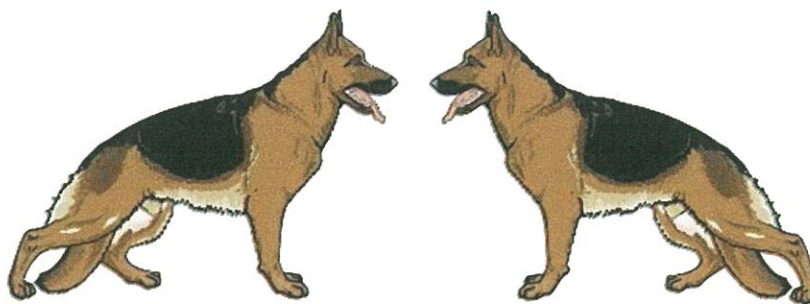

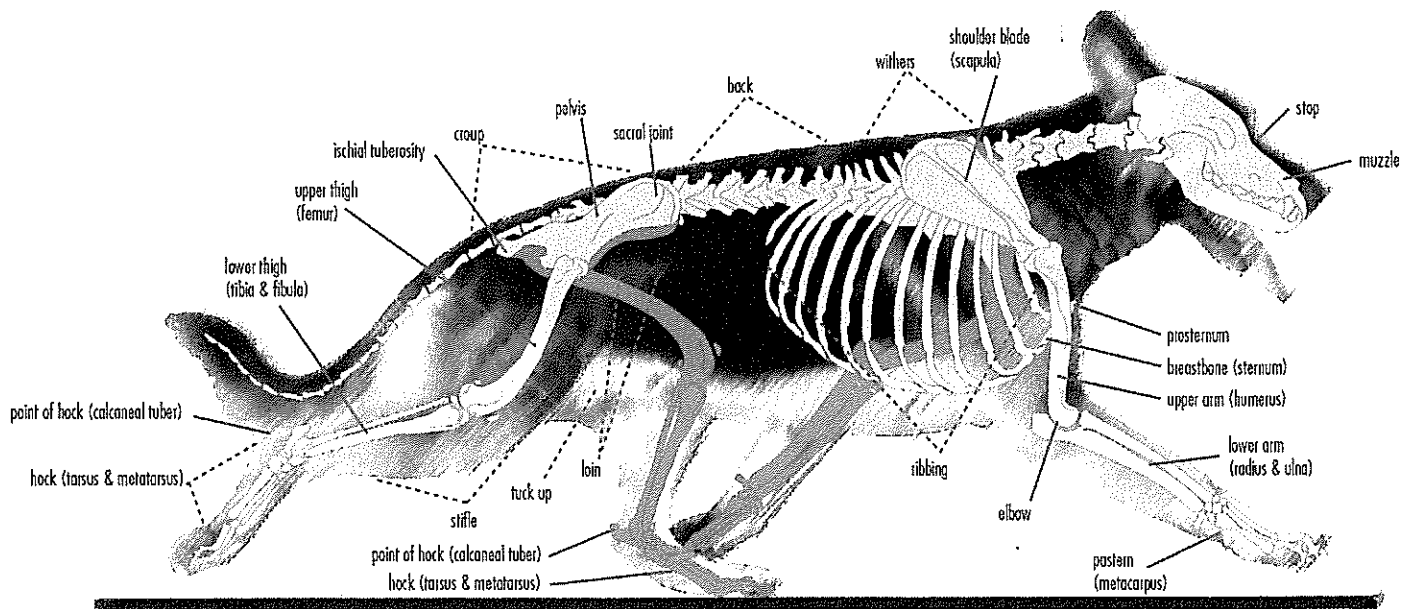
