#### ~ Noteworthy News for April 2017 ~

The AKC is constantly working on ways to expand our reach and our mission. While many changes are happening behind the scenes, it is our pleasure to make you aware of some of the initiatives our dedicated staff have been working on this month.

#### **AKC Spring Legislative Conference**

On April 30-May 1, 2017 we will host our Spring Legislative Conference and National Purebred Dog Day Celebration in Washington, DC. Led by our dedicated Government Relations department, this two-day conference is designed to educate, network, and share experiences with legislative liaisons in the Mid-Atlantic region and around the nation. Attendees will learn from the AKC Government Relations team and numerous experts about the latest trends, strategies, tips for community outreach and legislative success. There will also be information from professional lobbyists and a tour of the Capitol with the opportunity to meet members of Congress and their staffs.

The conference will culminate in a reception held at U.S.Capitol Visitor Center in honor of National Purebred Dog Day where guests will have the opportunity to meet "Rumor†, the German Shepherd Dog, winner of the 2015 AKC Eukanuba National Championship and the 2017 Westminster Kennel Club Dog Show, learn about advances in canine health research and meet breed representatives from each group. It will be an educational time for everyone involved.

#### AKC and the AVMA

As part of our mission to continue the advancement and well-being of all dogs, the AKC began meeting with members of the AVMA to discuss current issues that are affecting canine health and the veterinary community. The initial kick-off meeting occurred in February and touched upon topics of mutual concern. Members of these ongoing meetings will include AKC staff representatives, as well as Dr. Janet Donlin, CEO of AVMA, Dr. Michael Topper, AVMA President-Elect 2016-2017 Dr. Joseph Kinnarney, AVMA President-Elect 2014-2015, Dr. Mark Lutschaunig, Director of the AVMA Government Relations Division, Gail C. Golab, Chief Advocacy and Public Policy Officer, Kate Tormey, Assistant Director in our Division of State Advocacy, Dr. Kendall Houlihan, Assistant Director in our Animal Welfare Division.

The goals of this meeting and our ongoing dialogue are to explore the ways in which our two organizations can work together to enhance the welfare of dogs now and in the future and we are proud to collaborate with the AVMA.

#### **EMPIRE ACE AWARD**

The AKC was delighted to posthumously honor Bretagne, a Golden Retriever, who was the last surviving 9/11 search and rescue dog, with the 2017 Empire State Award for Canine Excellence (ACE) on Tuesday, March 21, 2017. This award recognizes canine heroes who have significantly contributed to the community while serving in the Empire State.

Bretagne was owned and handled by Denise Corliss before her passing last year at the age of 16. As members of Texas Task Force 1 Search and Rescue Organization, the pair responded to the World Trade Center tragedy in New York shortly after the September 11th attacks in 2001. Bretagne's first ever deployment was at the tender age of two, as a newly certified FEMA Search and Rescue Dog, searching through the debris and rubble of Ground Zero.

Denise accepted the prestigious award on behalf of her fallen partner, Bretagne, at a press conference at the American Kennel Club's new pet care space, AKC® Canine Retreat. Bretagne was a family pet as well as a source of comfort for the human teams working the tragic scene during a seminal period in our nation's history.

We are proud of her contributions and those of all working canine teams who keep our country safe.

This is an overview of some of the happenings at the AKC and ways in which we are carrying out our mission. We are proud to share our commitment to purebred dogs with you. Look for more updates next month.

# GSDC OF CENTRAL OHIO, INC. MEETING WEDNESDAY, MAY 17, 2017

The meeting was called to order at lacono's Restaurant at 7:40 by president John Ayotte. There were twelve members attending.

Minutes of the April meeting were read. Jeff Pyle moved minutes be approved, seconded by Joe LaRosa. The motion carried.

Sue Clark was not present due to the death of Roy's mother. There was no treasurer's report.

Secretary's Report: Rosemary Booth expressed her appreciation of Kathi Jo Zornes stepping in as secretary for the April meeting. AKC Event Plans was contacted as requested to ask if there has been change in their rules allowing a one-time move of show site by a club to share another club's. The rule stands that if our club were to hold shows in Cincinnati, Trumbull County Kennel Club would be allowed to hold classes for German shepherd dogs the same day, and they would then own the date. It would be up to them whether we could hold a specialty in Columbus the same day, and they could continue to offer classes for German shepherd dogs. Since we currently own the date for the area, neither Trumbull County Kennel Club nor Cincinnati Kennel Club have breed classes for German shepherd dogs. Communication was received from AKC regarding rules for non-regular classes and was forwarded to Kathi Jo. We do not hold non-regular classes. A list of judges for 2018 was sent to all members and ballots prepared for the meeting.

Show Secretary: Kathi Jo Zornes has provided Royal Canin puppy packs for winners of puppy classes. Since they exceed the number of puppies entered, it was suggested they be awarded to all puppies, and if there are any left over, they may be distributed to any who want them. Rosemary Booth read Kathi Jo's show report. She's working on the catalog and needs trophy and donor information. She needs a couple of coolers for pop and water for Brandon's concession. Parent club medallions have been ordered but not yet received. She's received AKC packets for both shows. Presently there is a 3-point major both sexes, both shows. She asked if the club is reserving a room and if so can she and Brandon use it. She needs to know what time judging is to start in the morning. She needs the information of the Parent Club contacts to whom she needs to send show results.

Show: There was discussion regarding time to start. Decision was made to start at 9:30 a.m. Second show will start 30 minutes after completion of a.m. show. Rosemary Booth moved moved the club reserve a room at the hotel, seconded by Joyce Willis. The motion carried. Grounds: we'll need four tents—two for ring, one for photographer, and one for food concession. With new ring equipment, rings can be put up Sunday morning (8 a.m.) before show. Joe LaRosa will pick up ring supplies at the fairgrounds. Joyce Willis will do the 50/50 raffle.

John Ayotte will check into alternative sites for 2018 spring specialty shows. Cincinnati is hosting 2018 Great Lakes Futurity, so he will follow up with them regarding their plans (date and site) for the futurity.

Teri Ayotte has reserved The Rusty Bucket, Hilliard for the board meeting/summer dinner event (instead of picnic). They did not have opening for June 21, so meeting will be on Thursday, June 22. Board will have brief meeting with dinner to follow. Notices with specific information will be sent to all members.

The subject of possible future fall specialties was discussed. Licking River Kennel Club holds shows in September at Lancaster, and an outdoor ring would be available.

After brief discussion, ballots were distributed with the following results: first choice Kathy Potter, second choice Charles Mardecz, third choice Bobbie Kindy, fourth choice Lee Brown, fifth choice Maryann Imhoff, sixth choice - Cathy Casteel and LaMar Frederick tied, seventh choice John Bemont and Rick Orlowski tied. Cindy Flautt received one vote, and Bart Barley, Michel Chaloux, and Doug Crane received none. Secretary is to call candidates at earliest opportunity.

The GSDC Of Greater Cincinnati has asked us to give the names of our judges and suggestions for theirs. They also request recommendations for futurity judge. John Ayotte will give them that information. Names mentioned for futurity included Linda Burley and Patty Korsch.

Joe LaRosa moved the meeting adjourn. Meeting adjourned at 8:30 p.m.

# Genetic Testing - What GenSol Offers GSD Breeders & Owners

The Orthopedic Foundation for Animals (OFA) maintains extensive data bases for a wide variety of canine and feline genetic diseases. GenSol Diagnostics offers a variety of breed-specific genetic testing to help you answer a number of questions pertaining to the genetics on your German Shepherd.

Easily read results are typically sent to an owner via PDF within 48 hours of receipt of the genetic tests from GenSol Diagnostics. The tests are simply donoted as the following:

A - means 2 copies of a normal gene is present and the individual is "clear" by the testing - Normal N/N

B - means 1 copy of a normal gene & 1 copy of an affected gene is present in the individual - Carrier N/A

C - means 2 copies of an affected gene is present & the individual is affected by that genetic condition

- Affected A/A

Please keep in mind that these test results given are *only* based upon the genetic markers typically checked per genetic condition tested- it does not mean that an indvidual cannot still develop the condition based on other outside factors. For example, a dog can be DM-Clear based upon the genetic markers tested, but could still possibly develop the condition later in life from *other* factors not taken into consideration in the genetic testing. And, there have been dogs denoted as DM-Affected but never show any signs of the condition throughout their lives.

The following is a list of tests offered for German Shepherds from Gen-Sol Diagnostics:

DM - Degenerative Myelopathy -incurable loss of mobility in the hind quarters, usually seen later in life

LENGTH - Coat type -cosmetic

CURL - Curly coat - cosmetic

D-LOCUS - dilute coat color - cosmetic

E-LOCUS - MC1R yellow coat color - cosmetic

HU - Hypouricosuria - formation bladder stones

MDR1\* - Multidrug Sensitivity -affects alot of herding breeds, sensitivity to Ivermectin & Loperamide

VWD1 - Von Willebrand's Disease Type 1 - abnormal blood clotting; least serious of the 3 types

\* - The MDR1 is the genetically inherited condition where a dog's system cannot properly filter harmful chemicals out of the brain, leading to a build-up of toxins. This toxic build-up can cause seizures, ataxia & death. Both carriers & affected dogs can have a severe if not fatal reaction to Ivermectin-based heartworm medications if given.

Each of the tests offered on the GenSol website have a data base that OFA maintains and is completed by a simple cheek swab by the owner [no blood drawn].

You must submit your results to the OFA-they are not automatically submitted by GenSol Diagnostics.

The dog you're having tested must have permanent ID through a microchip or tattoo before testing.

GenSol offers sales on their genetic testings routinely throughout the year. The costs for their genetic testing is as follows: \$40 for 1-2 individuals per test, \$30 for 5 or more tests ordered-regular price, or \$25 for 5 or more tests ordered-during sales events. For breeders wishing to start health testing their crew, ordering multiple tests at one time during a sale is a great way to do it affordably-the price is the same no matter what genetic test you order.

These test fees mentioned does *not* include the \$15 fee it costs to submit your results to the OFA.

If you are submitting a GenSol result to be added to the OFA Database, you must send a copy of your GenSol results along with the OFA Based Genetic Disease Form with the proper test you had done identified on the form & recording fee of \$15. So, in summary, health testing by breeders is truly a good thing and shows that they are trying to be mindful concerning the healthiness of their stock & the future of the breed. But, it is not a full-proof guarantee that a dog cannot be affected by factors outside of the parameter of the testing not taken into consideration with any offered tests. Health testing is just but one aspect of many to be taken into consideration in a well-rounded breeding program.



German Shepherd Dog "Rumor" (GCH CH LOCKENHAUS' RUMOR HAS IT V KENLYN) won Best in Show. Rumor was handled by Kent Boyles and was judged by Tom Bradley III.

She is named for the hit song "Rumor Has It" by Adele, a champion herself who had sweeping success when she won top song of the year, top record of the year and top album of the year at the Grammy Awards this month.

I have attended the prestigious Westminster Dog Show for the last 20 years and I thought the competition this year was the best. Rumor nearly won Westminster last year when she came to New York as the nation's No. 1 show dog with more than 100 overall ribbons but was beaten by a German Shorthaired Pointer named CJ. Rumor joined the fittingly named Manhattan "Hatter" as the only other German Shepherd Dog to go Best in Show at the Garden in 1987, handled by James Moses.

#### **AKC HEALTH: CANINE INFLUENZA UPDATE**

This notice is being sent out to provide up-to-date and accurate information about the Canine Influenza Virus to help prevent the spread of the virus to healthy (unexposed) dogs. The information provided is not intended to alarm dog owners and handlers.

There are recently confirmed cases of the Canine Influenza Virus (H3N2 strain) that was first brought to and identified in Chicago, Illinois in the spring of 2015. The most recent outbreaks concern the following states: Florida, Georgia, and North Carolina.

Canine Influenza Virus is an extremely contagious airborne disease that is easily spread among dogs, and in rare instances, can be contagious to cats. If you believe one of your dogs may have contracted the Canine Influenza Virus, immediately isolate it from other animals and contact your veterinarian. Here is some additional information about Canine Influenza Virus and tips for how to minimize the risk and reduce the spread of the disease:

#### Canine Influenza Virus

- Canine Influenza Virus is spread through:
  - Close proximity to infected dogs (it is airborne and can travel up to 20 ft.)
  - Contact with contaminated items (bowls, leashes, crates, tables, clothing, dog runs, etc.)
  - People moving between infected and uninfected dogs
  - 80% of all dogs that are exposed to the virus will contract it
  - The virus lives up to 24 hours on soft surfaces and up to 48 hours on hard surfaces.
- Some exposed dogs will be subclinical carriers meaning some dogs will contract and spread the virus without showing symptoms.
- Dogs show clinical signs within 24-48 hours and can shed the virus for up to 28 days from exposure.
- Most dogs will completely recover with proper treatment.
- Dogs that regularly interact with dogs outside of their own family or frequent places where many dogs gather are most susceptible to exposure to Canine Influenza Virus.

#### **Symptoms**

- Dry, hacking cough (similar to kennel cough)
- Lack of appetite
- Lethargy
- Discharge from the nose or eyes
- Fever (normal temperature is 101)

#### Prevention

- The best protection is vaccination. There is now a single vaccination for both the H3N2 and H3N8 strains of the virus. The vaccination requires a booster shot two weeks after the initial vaccine. Vaccination provides the best chance of immunity within 7-14 days of booster shot.
- Isolate sick animals and keep them isolated for up to 30 days after symptoms subside.
- Practice good sanitation. Use a bleach and water mixture diluted to 1-part bleach x 30 parts
  water to disinfect common areas such as tables, bowls, leashes, crates, etc. Allow items to
  thoroughly air dry for a minimum of 10 minutes before exposing dogs to them. Bleach breaks
  down quickly so solution should be made daily. Keep in mind that bleach becomes inactive in
  UV light. If mopping use two buckets so as not to cross contaminate areas
- Wash your hands frequently, ideally between handling different dogs. At the very minimum, hand sanitizer should be used between handling dogs.
- Use disposable gowns or wipe down clothing and shoes with a bleach solution between dogs or after leaving an area where dogs congregate.
- Food/water bowls should be made of stainless steel instead of plastic because scratched plastic is hard to fully disinfect.

#### **Treatment**

- Treatment of Canine Influenza Virus requires veterinary assistance. If you believe your dog
  may have Canine Influenza Virus, please contact your veterinarian immediately. Untreated,
  the illness may progress to pneumonia or other, more serious problems. H3N2 can lead to
  severe secondary pneumonia which can cause extremely sick dogs with potential fatalities.
- Most dogs take 2-3 weeks to recover from the illness.

#### Containment

- Any dog suspected of having Canine Influenza Virus should be immediately isolated from other dogs and should not attend dog shows, day care, grooming facilities, dog parks, or other places dogs gather. Dogs are contagious for up to 30 days once they have started showing symptoms.
- Contact your veterinarian to let them know that your dog may be showing symptoms of Canine Influenza Virus. If your dog is going to a veterinary hospital or clinic, call ahead to let them know you have a suspected case of Canine Influenza Virus. They may ask you to follow a specific protocol before entering the clinic to minimize the spread of the disease, including waiting in your car until they are ready to examine your dog.
- Keep sick dogs at home and isolated from other dogs and cats until you are certain the illness has run its course (typically 3-4 weeks).

#### **Consideration for Event Venues**

- Use a bleach and water mixture diluted to 1-part bleach x 30 parts water to disinfect common areas including show floors, grooming tables, ring gates, in-ring examination tables and ramps, and x-pens. Allow solution to completely dry (at least ten minutes in order to assure virus has been killed). Bleach breaks down quickly so solution should be made daily. Keep in mind that bleach becomes inactive in UV light. If mopping use two buckets so as not to cross contaminate areas.
- When wiping down hard surfaces paper towels are preferred over cloth.
- Consider having two exam tables at every ring so that they can be cleaned and allowed to air dry frequently in between classes.
- Provide hand sanitizer in each ring and in grooming areas.
- Exhibitors should consider grooming dogs at their cars instead of using grooming areas where dogs are in very close proximity.

Dr. Jerry Klein is a veterinarian in the emergency room at Chicago's largest veterinary emergency and specialty center. He was personally involved in treating hundreds of dogs sickened by the H3N2 virus during its initial outbreak in Chicago in spring of 2015. He is also an AKC licensed judge.

#### ~ AKC Announces SCENT WORK as a New Sport ~

The American Kennel Club, the leading authority on dogs, is pleased to announce the launch of its newest sport, AKC Scent Work. Scent Work is a sport that mimics the task of working Detection Dogs - such as narcotics dogs or explosives dogs - to find a specific scent and communicate to the handler that the scent has been found. It is a positive, challenging activity that allows dogs the opportunity to use their strongest natural sense in a way that is fun, engaging, and that builds and strengthens a foundation of trust between the handler and the dog.

In AKC Scent Work, the dog is searching in a pre-defined search area for the hidden odor, which is either an essential oil or handler scent, depending on the class. Searches take place in a variety of environments, including an area with Containers, Interior, Exterior, and Buried. There are four difficulty levels for each element: Novice, Advanced, Excellent, and Master and factors such as the size of the search area, the number of hides, whether the number of hides is known or unknown to the handler, and the maximum height of the hides will change with the difficulty level. The most accomplished dogs will also be eligible for The Detective Class, which contains many hides in a variety of environments.

All dogs (purebred and mixed breeds) can participate provided they are AKC-registered, enrolled with AKC Canine Partners, listed in the Purebred Alternative Listing (PAL) program or recorded in the Foundation Stock Service (FSS) program. "We have already received significant interest from clubs, participants, and potential judges," said Stephanie Kennerley, Sports and Events Project Coordinator in charge of Scent Work, "Scent Work provides a stimulating activity for dogs. Owners will enjoy watching their dogs use their nose to solve these unique puzzles. We are excited to make this activity a new AKC sport."

Because of the tremendous interest, the sport will be ramped up in phases. The AKC is currently accepting applications from existing and new clubs seeking to become licensed to hold Scent Work trials. Approved clubs are being notified and Scent Work will be added to their club profiles beginning May 1. Applications are also being accepted for Scent Work judges. A judge's education class is under development and is tentatively scheduled to be available by May 1. A list of approved judges will be available on the AKC website after June 1. Processing of event applications will begin on August 1. Scent Work trials can be held on or after October 1, 2017.

AKC Scent Work is a modern day performance event in which bred-for traits like working drive, concentration and response to distractions are redeployed into roles relevant for the twenty-first century," said Doug Ljungren, Vice President of Sports and Events, "While the sport of Scent Work will not prepare your dog to be a working detection dog, we hope it serves to demonstrate to the public the value that these purpose-bred dogs can provide to the security of our nation."

#### NEW AKC TRICK DOG TITLE PROGRAM LAUNCHED IN MAY 2017

AKC Trick Dog titles are official AKC titles listed on the dog's title record, earned for being able to dazzle with a dog's talent at learning tricks. The processing fee for each title is \$20. Dogs must have an AKC, PAL, or AKC Canine Partners number to earn a title.

Through December 31, 2017 the AKC is grandfathering in any dog who has previously earned any of the Do More With Your Dog trick titles Novice - Champion; an owner only needs to provide proof of the highest level of DMWYD title earned and the \$20 recording fee to have the highest corresponding title added to their dog's name.

The levels of AKC Trick Dog title are Trick Dog Novice [TKN], Trick Dog Intermediate [TKI], Trick Dog Advanced [TKA] and Trick Dog Performer [TKP]. The highest level, TKP, must have a video or DVD sent to the AKC of the dog performing the minimum 10 tricks in the acceptable levels to be awarded the Performer title. 
